ORDERS BY THE GOVERNOR OF ASSAM NOTIFICATION

Dated Dispur, the 18th Sept' 2014

PMA. 627/2010/289: In exercise of the powers conferred by the Section 32(1)(2)(3)(4) of the Right of Children to Free and Compulsory Education Act, 2009, the Govt. of Assam is pleased to notify the following provision for grievance redressal mechanism.

(1) Any person having any grievance relating to the right of a child under the said Act may make a written complaint to the local authority;

(2) The local authority after receiving the complaint from the applicant, shall decide the matter within a stipulated period of three months affording a reasonable opportunity of being duly heard to the parties concerned;

(3) Any person aggrieved by the decision of the local authority, shall prefer appeal before the State Commission for Protection of Child Rights and the Appellate Authority i.e. State Commission for Protection of Child Rights shall dispose of the appeal within a period of three months.

Whereas in exercise of the powers conferred by the section 32(1)(2)(3)(4) of the RTE Act, 2009 and Assam Right of Children to Free and Compulsory Rulles, 2011 framed there under the Government of Assam in the Education Department (Elementary) is pleased to notify the following Grievance Redressal Framework.

The Grievance Redressal agencies responsible for receiving and addressing of the grievances from village/town level shall take followings actions:-

> Local Authority will receive written complaint from any person (any child, parent or guardian or any other on behalf of any child) by post, fax, email, toll free telephone number etc. and will record in the prescribed format.

- > The identity of the complainant will be kept confidential.
- > The Local Authority will register the complaint and will acknowledge the complaint. A receipt of the complaint should be provided to the complainant.
- > Local Authority will maintain all records of grievances filed and decisions taken on it.
- > The Local Authority will investigate the complaint and thereafter take decision on the complaint.
- ➤ If the complaint is not redressed, the Local Authority will forward the matter to the District Level Authority or the complainant may directly appeal to State/District Level Authority and State Commission for Protection of Child Right (SCPCR) in this regard.
- In respect of grievances of an urgent matter such as denial of admission etc. the notified authority shall endeavour to decide the matter in the shortest time-possible.
- > In respect of grievances related to violation of Indian Penal Code, such as violence, child abuse, corporal punishment etc. the notified Local Authority may facilitate the filing of FIR before the Police authorities and intimation to the respective CWCs(Child Welfare Committees)under the Act.
