ORDER BY THE GOVERNOR OF ASSAM
NOTIFICATION

Dated Dispur, the 10th June, 2016

AEE.143/2016/24: The Governor of Assam is pleased to notify the Directorate of State Council of Educational Research and Training (SCERT), Assam as State Leadership Academy, Assam with the prime purpose of transforming schools into centers of excellence, leading quality in school education in the State in collaboration with National University of Educational Planning and Administration (NUEPA) through National Centre for School Leadership (NCSL). SCERT, Assam will facilitate and drive quality improvement in schools based on local needs and contexts for transforming education up to the secondary stage of school education in Assam. SCERT, Assam will act as nodal centre for school leadership development and be responsible for executing the following activities and training programmes-

1. Organizing different programmes for school level functionaries and local community leaders in the education sector.
2. Empowering through training current and prospective leaders of school education-Principals, Vice-Principals, aspiring school heads, senior teachers, existing and freshly inducted school principals, Systemic Administrators and persons in leadership positions.
3. Conducting training for Heads of elementary, secondary and senior secondary schools, Government schools, private schools and schools receiving grants-in-aid from the Government. The fund for this purpose is available under SSA and RMSA for educational administrators and Head teachers in the State.
4. Implementing the programme in tune with the NCSL curriculum framework on School Leadership Development.
5. Creating teams of Resource Persons to act as arms of the Academy to organize State/field/school based Workshops.
6. Building capacities of Resource Persons and extending support in carrying out activities in different districts.
7. Engaging Principals and Headmasters in networks and Professional Learning Communities (PLC) for school improvement and ensure systematic identification and sharing of experiences.
8. Making Leadership Academy vibrant in the functioning of activities as identified by NCSL and to carry out research activities in the state involving universities and other professional institutions.

This notification will come into force from the date of issue of this notification and publication in the official Gazette thereafter.
